

OPEN ENROLLMENT FOR MEDICAID AUTISM WAIVER PROGRAM

The Department of Health is pleased to announce the open enrollment dates for the Medicaid Autism Waiver Program. The Department will be accepting applications to fill 35 openings. From June 17, 2013 to July 12, 2013, interested families can apply online at http://health.utah.gov/autismwaiver or by mail or fax. Printable copies of the application are available on the website.

Interested individuals who have children currently enrolled in traditional Medicaid <u>will not</u> be automatically eligible for the program and will need to apply. Children currently participating in the Medicaid Autism Waiver Program will not need to reapply.

At the conclusion of the open enrollment period, if more than 35 applications are received, random selections will be made based upon geographical area, with openings allocated according to population figures from the 2010 Census. The Department of Health will be making contact with those selected during the week of August 5-9, 2013. Individuals are not selected on a "first come, first served" basis, so please encourage anyone who may be able to benefit from the program to apply.

In order to be eligible for the program, additional medical documents will be requested to support the Autism Spectrum Disorder diagnosis received. For examples of the types of observations that will be required, please visit the website at http://health.utah.gov/autismwaiver

UTAH POST HIGH SCHOOL OUTCOMES PROJECT

In June, youth who exited school during the 2011-12 school year by graduating with a high school diploma, reaching maximum age (age 22), or dropping out, will be contacted to participate in a telephone survey about their activities since leaving school. The results of the survey are reported in Indicator 14 of the Annual Performance Report submitted each February to the Office of Special Education Programs by the USOE. The telephone survey is designed to protect confidential information; results are reported for the entire district or charter school, and are not available for individual students. Parents or other family members may answer the questions if the former student is not available or is unable to participate in the survey. Participation in the survey is voluntary, but the results help school districts and charter school improve secondary transition programs leading to better postsecondary employment and education options for students with disabilities.

CLIENT ASSISTANCE PROGRAM CAN HELP STUDENTS WHO ARE TRANSITIONING TO EMPLOYMENT!

Students who are transitioning from school into employment or further education will most likely be introduced to Vocational Rehabilitation (VR) as they develop an individualized education program (IEP) focused on transition services. Students who have an IEP and are receiving special education services, may be eligible to receive services from VR while they are in school.

VR's goal is to help individuals with disabilities in facing a number of challenges finding and maintaining employment. There are a number of resources available to assist individuals with disabilities navigate unique challenges to employment. One of these resources is the Client Assistance Program (CAP) at the Disability Law Center. The CAP program is designed to protect the legal rights of people who apply for or are already clients of Utah's VR program. This means that CAP may be able to help you if you feel that your VR counselor has denied you a service or found you ineligible for services. If you just don't feel right about the services you are receiving from VR, feel free to contact us. We are happy to review your situation. Our services are free of charge. Here are a few things that CAP can help you with:

- Work out problems between you and your VR counselor.
- Make sure you get the services from VR that you need to get a job.
- Teach you how to protect your rights and stick up for yourself
- Assist you in appealing a denial of Vocational Rehabilitation Services.
- Explain your rights and responsibilities as a VR client so you can understand them.
