Reflections is a National PTA program that encourages students to use their talents to create works of art in categories such as Visual Arts, Literature, Music, Photography, etc. Student winners from the local level can move up through council, region and state programs to the national level. The Special Artist Division is an option for students with disabilities who may need accommodations to participate fully in the program.

# **Resolutions - HIGH EXPECTATIONS FOR STUDENTS WITH DISABILITIES**

PTA Resolutions are official documents outlining the association's opinion, will, or intent to address problems, situations, or concerns that affect children and youth and require action to seek resolution on the issue.

Since 2013 with the creation of a **Special Needs Committee**, Utah PTA has had a particular focus on children with disabilities and their families. In 2017 Utah PTA passed a resolution on **High Expectations for Students with Disabilities**. In 2018 Utah PTA presented the resolution at the National PTA Convention, where National PTA also adopted it. In 2019 Utah PTA worked with the legislature to pass a Utah Legislative resolution on **Encouraging High Expectations for Students with Disabilities**. National PTA also has a resolution called **Inclusive Schools Build Stronger Communities**. These resolutions are public documents and can be shared with others. They can be found on the Utah PTA website.
